## Appendix No. 2 to the registration form

### DATA PROTECTION COMPLIANCE STATEMENT

Pursuant to Articles 13 and 14 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (Official Journal of the European Union L. 2016.119.1, as amended), hereinafter as the GDPR, I inform that:

1. The controller of your personal data is Willa Lentza, with seat at 84, Wojska Polskiego Ave., 70-482 Szczecin, Poland.

3. Making your personal data available is voluntary, but it is necessary for the purposes for which they are collected. Refusal to make these data available will make your participation in the SAXandVILLAS – 2023 International Composers’ Competition and the processing of your Competition entry impossible.
4. Your personal data shall be processed for the purpose of registering for the Competition, processing your entry, organising the Competition, the use by the Organisers of the audio and video recordings, radio and television broadcasts and online streaming of the Competition’s public sessions, as well as, in case you are awarded the 1<sup>st</sup>, 2<sup>nd</sup> or 3<sup>rd</sup> prize in this Competition, for the Organisers and Competition Participants to use the Recorded Performance, on conditions specified in the SAXandVILLAS – 2023 Competition Regulations.
5. Your personal data shall be processed pursuant to Article 6 section 1 item a of the GDPR (“the data subject has given consent to the processing of his or her personal data for one or more specific purposes”).
6. The recipients of your personal data are members of the Jury, including its President; persons who will have access to the audio and video recordings, radio and television broadcasts and online streaming of the Competition’s public sessions; persons who will have access to the Recorded Performance; subjects processing personal data on behalf of the Organisers, in particular: subjects providing services to the Organisers, and performing accountancy services; other data controllers acting pursuant to agreements signed with the Organisers, including:

8. You have the right to access your data, to rectify, erase, limit the processing of your data, as well as transfer your data and the right to object.
9. You have the right to withdraw your consent at any moment without affecting the right to process the data based on your consent until the moment of withdrawing it.

10. You have the right to lodge a complaint to the personal data protection supervisory authority (at present: Inspector General for the Protection of Personal Data), in case you conclude that the way your personal data are processed is in violation of the GDPR.
